



Mt. Sima Alpine Adventure Park Paragliding Policy

Please read carefully. The following is a mandatory structure for the paragliding policy at Mt. Sima Alpine Adventure Park. This applies for both winter and summer operations. The goal is to have a fun and safe paragliding program for all.

Airspace

- The area around the park below 700 AGL is class G airspace and open to all
- Above 700 AGL is class E airspace and pilots require HGAR & Air-band Radio
- Small aircraft, helicopters and float planes arriving/departing CYXY and Schwatka Lake often overfly the airspace around Mt Sima

Communications

It is MANDATORY to contact the airport control tower/FSS prior to launching and when finished.

Launch and Landing sites and No Fly Zones

Launch and Landing sites

- Designated takeoff and landing sites are established by Fly Yukon Paragliding and must be adhered to unless in the case of an emergency. Visit www.flyyukon.com for details.
- **Pilots must not land anywhere else**

No fly Zones

- **DO NOT** fly below tree top elevation over runs (Pilot not below tree line)

Set distances from lifts and buildings are as follows:

- Vertical separation is 100 feet minimum
- Horizontal separation is 100 feet minimum

Rescue

All pilots will have a self rescue kit and plan for self rescue prior to launch. ***You are using the facilities at your own risk. Mt. Sima Alpine Adventure Park assumes no responsibility. Mt Sima Patrol will only assist inside ski area boundaries.***



Pilots

- All pilots must have proof of current HPAC insurance.
- Tandem pilots must have proof of current Tandem endorsement.
- Unrated or student pilots must be under direct supervision of an HPAC Instructor.

Rules of flying at the Park

1. Pilots must sign this document, highlighting the specific rules of flying at the Park.
 - a. **READ, UNDERSTAND AND INITIAL NO FLY ZONES**
2. Pilots must have a Self rescue plan and equipment.
3. **You must have a season pass or lift ticket with paragliding identifier in order to board the lift.**
 - a. Season Pass Holder: Complete waiver and proof of insurance to receive a paraglider icon on your season pass.
 - b. Day Visitors: Day ticket will be issued at the Mt. Sima Guest Services upon proof of insurance and signing of this form.
4. Day tickets will only be issued when weather conditions permit paragliding. This includes full visual from Top Chair to Mt. Sima Lodge with winds not in excess of 25 km/hr.
5. **No speed flying** allowed at any time.
6. Summer access will be via quad lift only during operating days.
7. Access will be permitted from lift opening to **30 minutes** prior to shutdown. Pilots equipped with skis will be permitted access no less than **20 minutes** prior to shutdown.
8. Pilots unable to launch must download on the chair at shutdown or descend on skis no less than **10 minutes** after shutdown.

Anyone found accessing the site without registration and waiver documentation completed; or not complying with the above rules will be prohibited from flying at Mt Sima and reported to HPAC.
